Copeland Center

Purpose

Doors to Wellbeing, a program of The Copeland Center for Wellness & Recovery, Inc., receives partial funding to operate the Substance Abuse and Mental Health Services Administration (SAMHSA)-funded National Technical Assistance Center to strengthen and support the peer support workforce. Through a national environmental scan, Doors to Wellbeing aimed to understand better how Peer Specialist roles and job descriptions have grown, changed, and evolved.

Given the wide variety of jobs and responsibilities assigned to Peer Specialists, our goal was to assess how closely Peer Specialist job descriptions align with the advertised job descriptions and if the Peer Specialist believed the job aligned with their certification training. We hope the results will demonstrate the growth and potential of the Peer Specialist jobs align with the <u>Core Competencies</u> for Peer Workers established through SAMHSA BRSS TACS (Bringing Recovery Supports to Scale).

Methods

The research process was thorough and comprehensive. The surveys were finalized in June 2023, and the first emails were sent in August 2023. Over 49,000 emails were sent to various Peer Specialists and agencies across the country. The survey was meticulously designed, comprising both closed and open-ended questions. These questions covered a wide range of aspects, from the state they lived in, current job title, description of job responsibilities, if peer certification is required, if the role matched the job description, and if the job meets their expectations, among others. This attention to detail ensures the reliability and validity of our research. For the privacy of participants, identifying information pertaining to the individual or agency was removed. We chose to group the information by state due to state certification requirements varying from state to state.

Sample

The survey was presented online for participant access and data collection. Announcements about the survey were emailed to various organizations (national and local) and other stakeholders. The final sample included completed surveys from 628 Peer Specialists in 47 states, including the District of Columbia. Of the states represented, the states with the highest participation were New York (67), Pennsylvania (61), California (59), and North Carolina (56). There were respondents not included in the results due to residing outside the United States. In total, there were 7 outside the US, 6 in Canada, and 1 from Ireland.
